





Congregation Meeting Minutes

November 17, 2024

Meeting was called to order at 10:00 am.

Pastor Tony started the meeting with a prayer.

Rich DeLuca, council President, discussed purpose of meeting – 2025 budget, 2025 council elections, and 2 additional items.

Laura Moyer, treasurer, presented the proposed 2025 budget.

Floor was opened for questions after the presentation.

One question was posed regarding the sustainability of the budget increase year over year

Laura pointed out that salary increases are a large part of the increase and they have not been modified in several years. Also, we are always monitoring expenses as our costs increase to ensure we stay within our budget. The 2024 actuals will come in under budget and we will continue to seek cost savings each year.

Rich supported these and took a moment to thank both Erica and Pastor Tony for what they do for our church, including Erica covering the medical insurance and Pastor Tony for being able to manage both Dinkey and St. Johns.

Rich then called for a motion to approve the budget. Dan Schwartz made the first motion, Lori German seconded the motion, all were in favor, none opposed.

Pastor Tony took a moment to thank Linda Bierman for her 2 back-to-back terms on council as well Brian Schell for his 2 years served on council.

Elections were then discussed.

There are four 3-year terms and one 1-year term to fill on council.

Rich nominated Dan Schwartz to fill the 1-year term and Dan accepted the nomination.

Rich and Pastor Tony mentioned that both Rich DeLuca and Karen Schleicher were nominated to serve two of the 3-year terms and both accepted their nominations.

Rich opened additional nominees to the floor but none were made. It was noted that without nominations for the two open 3-year terms, council could appoint 2 members to serve in these roles for a maximum of one-year.

Rich asked for a motion to re-elect the three nominees (Dan, Rich, and Karen).

Jay Frey 1st, Kurt Steigerwalt 2nd, All in favor, none opposed.

Pastor Tony then noted that the audit committee of Angela Rothermel, Kristen Markell, and Nora Oswald all agreed to serve again in 2025. He also mentioned that the financial secretary, Kelli DeLuca, and treasurer, Laura Moyer, also agreed to continue to serve in their financial roles in 2025.

Rich noted that Jim Koch agreed to serve the 3-year term for the cemetery board.

Motion requested to accept these, Kurt Steigerwalt 1st, Jay Frey 2nd, All in favor, none opposed.

Two proposals were discussed next by Rich

The first proposal was for the sound/audio system. Since only one bid was in at the time of the meeting, this proposal was tabled until the February Congregational meeting.

The second proposal was for the restoration and protection of our stained-glass windows. A quote from The Baut Studios, Inc in the amount of \$184,180 was presented for review.

Rich mentioned that the synod can provide loans for this type of expense with a 3% interest rate, 10 year term, and no penalties for early pay off.

There were several concerns brought up by members including having debt and being able to afford the monthly payments (roughly \$1740/mo).

Erica Pagotto made a motion to fundraise and do one side at a time. Sonny seconded this motion.

This led to more discussion around the maintenance that would be required for this work – Jay mentioned it was nothing excessive.

There was also discussion around what side we would start with and how long we would fundraise before beginning any work.

After further discussion, there was a motion to rescind the current motion so we can fundraise and find out how long the current quote will be honored. This will also be tabled until our February meeting (and will allow time to start fundraising).

Motion to close meeting was made at 10:54. Jim Koch and Dan Schwartz were 1st and 2nd, respectively. All were in favor, meeting adjourned.

SUMMARY:

It's hard to believe that at the end of 2024 we have been together in ministry for over 16 years! How time flies by! It's been a great year together and here are some of the highlights.

On the congregational level I need to begin with the Purchase of Service Agreement with St. John's. I am extremely grateful for the mutual care and cooperation between Dinkey and St. John's as both congregations work well together and desire what is best for one another. We have been able to share in many areas of ministry such as confirmation and First Communion instruction, Vacation Bible School (I really enjoy the adult class), Midweek Advent Worship and Soup Suppers, Election Day Spaghetti Dinner, blessing of the Animals, the CROP Walk, CPR Training, the August joint worship and picnic, Christmas caroling, and the newly started Fermenting Our Faith.

It has also been wonderful to see the continued cooperation between the five local churches (Dinkey, St. Johns, Ben Salem, St. Peter's, and Zion Stone) for the Thanksgiving, Ash Wednesday, and midweek Lenten worship services. I am so looking forward to seeing how else we can be sharing together in ministry.

On the community level I participated in the career day at the Lehighton Middle School where I shared with students my path to the ministry and what it could look like for them. I assisted with the Fire Prevention Program at the Elementary Center meeting with the kindergarten, 1st and 2nd Graders to talk about "Stop, Drop, and Roll" and other safety issues. I coached the middle school track and field team and the cross-country team, both of which have been incredible opportunities to make connections with the youth and others in the community. I also served as chaplain and secretary for the East Penn Township Volunteer Fire Company.

On the synodical level, I attended the Bishop's Conference from February 6-7, and the Northeastern PA Synod Assembly at Atonement Lutheran Church in Wyomissing with our congregational representatives on June 8. I served on the Hazleton-Lehighton Mission District Council which meets quarterly and deals with matters related to the local Lutheran congregations' relationships with the Bishop's office and Synod Council. I was also invited to serve on the Licensed Lay Ministry Formation and Advisory Team. This is a newly started team that will help to coordinate and oversee the process for those looking to become Licensed Lay Ministers within the NEPA Synod.

Personally, I cannot discuss 2024 happenings without mentioning Claudia's illness in the Spring. It was a very stressful and scary time for us as a family, and we will forever be grateful to all of you for your prayers and support throughout that journey. You were truly a church family, and your love touched our very souls. Thank you!

Thank you as well for the opportunity to continue being your pastor. I am honored to serve in this role and pray God may guide me to be the best pastor I can be for each and every one of you.

Cemetery

In 2024 the cemetery met on as needed basis. We added a new member to the Cemetery team with Jim Koch joining the team.

We continue with John Reedy as the caretaker of the cemetery and he has done a fine job. Compared to most in the area our cemetery is exceptional in its care of the property including the mowing of the church property and parsonage.

In 2024 we had 29 lots sold as we are an open cemetery, and lots can be purchased by anyone who wants to be buried or have a family member buried here. In addition, we had 14 burials for 2024.

Funds in the beginning of 2024 for the perpetual care was 42,7854.20 and the 2024 year end balance is 47,3374.34, and this included a market correction of 16,980.54 in December. In the general fund the beginning balance was 118,300.38 and the ending balance was 130,856.51 and this included the correction of 4,752.74. The checking account that all bills are paid from has a balance of 10,368.04. This is used to pay for the daily expenses of the cemetery.

In 2025 we are going to start back with a quarterly Meetings. Also, the Cemetery in 2024 has offered a donation to the church of 20,000.00 to be used for the windows or the sounds system as needed. These funds have not yet been transferred.

PROPERTY COMMITTEE REPORT 2024

There were a lot of projects in 2024, both large and small (not all small ones listed).

The bell tower leaks were fixed, its foyer floor was replaced, walls painted, chairs and antique alter were refinished and a new coat rack and umbrella stand were purchased. New entry rugs were purchased for all entry doors to the church.

A new entry lock and deadbolt were installed in the door to the church office. A new key lock box was purchased and installed and a new fire proof file box was purchased.

Pew pencils purchased and holders in church refilled. Downspouts reconnected to drains in ground with new connector pipes. Timers for parking lot lights adjusted throughout the year. Dim LED bulbs in the foyers and parlor were replaced with brighter LED bulbs. The old piano and pump organ were removed from the foyer. New first aid kits, an AED defibrillator and a new cabinet for those items were purchased. The vacuum cleaners were repaired and locks were installed on David's storage closets. Church van inspected and oil changed. Carl Schleicher was rehired to plow snow and salt the parking lots as needed

The parsonage water system was updated with new water softener tank, well tank, UV light, and water heater.

The security cameras were repaired and the screens moved to the office so the secretary could monitor them from her desk.

Spring cleanup was held in May. Mulch was spread at the playground, the garage was cleaned out, the church door windows cleaned and pews wiped down. The bushes were trimmed and beds weeded in spring and fall.

A security mailbox was installed along the road for mail delivery and the P.O. Box discontinued.

Baut Studios Inc. came in to inspect our stained glass windows and gave us a quote to repair the windows, remove the old Plexiglas coverings and replace them with glass.

Almost all wrought iron railings outside were cleaned and repainted as a community service project.

The church water softener malfunctioned and leaked. Water was cleaned up and system replaced.

The old air conditioners in the church stopped working properly. Quotes were obtained and a contract awarded to remove the old units and replace them with new heat pumps for A/C and heat.

Water was leaking into the north (back) stairway of the church basement. The roof was sealed were it connected to the stone wall of the church.

A new sound, video and streaming system for the church was quoted and presented to Council.
